

Town of Marshville Town Council Meeting

Thursday, June 22, 2017, 7:00 PM Marshville Town Hall

Special Meeting Minutes

Present: Mayor Frank Deese; Mayor Pro-Tem Morgan; Council Members Margaret Bivens, Norma Carpenter and Ernestine Staton. Council Member Rowell was absent due to illness. A quorum was present.

Staff: Scott Howard, Interim Town Manager; Tonya Johnson, Town Clerk/Finance Officer; Matt Tarlton, Police Chief & Acting Public Works Director

Call to Order/Invocation/Pledge of Allegiance

The special meeting was called to order at 7:00 pm by Mayor Deese. The invocation was given by Council Member Carpenter. The Pledge of Allegiance was given by everyone.

Adoption of Agenda for the Meeting

Mayor Pro-Tem Morgan made a motion to adopt the agenda. The motion was seconded by Council Member Staton and passed unanimously.

Public Hearing regarding the proposed FY2017-18 Annual Budget, Fee Schedule and Meeting Calendar

A motion to open the public hearing was made by Council Member Bivens. The motion was seconded by Council Member Carpenter and passed by unanimous vote. Interim Town Manager Scott Howard commented that the proposed budget that the council members have before them has been gone over quite thoroughly. He stated that he will be glad to answer any questions. Mayor Deese opened the floor to those individuals desiring to speak regarding the proposed budget.

Fred Burton, 708 E. Union Street, Marshville, NC, commented on the signs in the proposed budget. Mr. Burton stated that he is reluctant to endorse such a capital measure. He explained that these signs are often a distraction to drivers. Mr. Burton added that Wingate's sign promotes the university, not the Town of Wingate. Mr. Burton stated that the sign doesn't generate revenue. It costs the citizens money. Mr. Burton pointed out that the water and sewer systems need repair and he is of the opinion that the town would be better served by other priorities. Mr. Burton acknowledged that the town can't retain good department heads. He stated that money might be better spent making salaries more competitive. Mr. Burton suggested that the signs be purchased at a later date.

Mayor Deese commented that the LED sign is currently outside of what the ordinance allows. The council intends to go through the proper protocol to change the ordinance. Council Member Bivens asked Mr. Burton how long he has resided in Marshville. Mr. Burton stated that he has lived in Marshville between 12 and 13 years. Council Member Carpenter explained that the council's thought process is to use the sign to advertise public information since Marshville no longer has a local newspaper. It will be used to advertise meetings and town events. Council Member Carpenter stated that the town is looking at a lease-purchase option. Mayor Deese added that the Randy Travis signs

were removed without the council's knowledge or consent. There was a public outcry to replace the sign. Mayor Deese stated that the council thinks Marshville will be better served to replace the Randy Travis signs. Council Member Staton remarked that citizens have requested that the signs be replaced. Mr. Burton concluded his remarks by asking the council if other priorities should be addressed first.

Susan Drake, 306 S. Elm Street, Marshville, NC, asked that the council put their most earnest efforts forward to bring the sewer lawsuit to an end. Ms. Drake stated that there is an urgency to bring the lawsuit to a conclusion.

Ms. Drake requested that, going forward, the council and the Planning Board meet jointly on a regular basis. Ms. Drake feels that information should be shared with the Planning Board. She mentioned the southern loop and the corridor study and the need for information to be shared.

Ms. Drake spoke regarding the LED sign. She stated that maybe she over analyzes things, but if the council is already setting aside tax dollars then the council's mind is already made up. Ms. Drake stated that the current ordinance does not allow for LED signs. She commented that some of the ordinances are being reviewed. Ms. Drake asked if the \$.03 tax increase to pay for the sign, park equipment, and additional money to the Beaver Land Volunteer Fire Department will be reduced next fiscal year, after these items are purchased. She asked the council how long the town can sustain legal fees at \$200,000 per year. Ms. Drake commented that the only one's making money are the attorneys. Ms. Drake stated that she is aware that the lawsuit is a tricky situation. She expressed her opinion that the town wouldn't be in the lawsuit if the town had paid its sewer treatment bills. The town should have paid something! Ms. Drake commented that it is her understanding that the county offered to pay something. She expressed that some decisions that were made seem political and/or personal. Ms. Drake concluded her comments by stating that she feels the council is delusional to think the county is going to pay the town millions of dollars.

Mayor Deese agreed that joint meetings between the council and the Planning Board are a good idea. Mayor Deese commented, regarding the southern loop, that a decision was made to remove it from the plan; however, information came to light. Mayor Deese stated that the county called and after some discussion, it was the consensus that the corridor study will be completed before a decision is made to remove the southern loop from the plan.

Mayor Deese made some clarifying remarks concerning the sewer lawsuit. He stated that he was in the meeting with the county and that the county never asked how much they owed the town. Mayor Deese stated that the county was asked to provide records and calculations. He stated that the county offered to pay approximately \$90,000+/-. Mayor Deese agreed that the lawsuit needs to be settled. He stated that the town's attorneys have requested mediation at least three times. The county has only requested mediation once, and they only wanted county staff to be present. Mayor Deese expressed his opinion that he doesn't think the attorney for the county desires mediation. Mayor Deese commented that, on behalf of the entire council, he is working on other avenues to work toward a resolution. Mayor Deese reiterated that he agrees that the lawsuit needs to be settled.

There were no further council comments or questions pertaining to the proposed FY2017-18 Budget, Fee Schedule and Meeting Calendar. A motion to close the public hearing was made by Mayor Pro-Tem Morgan. The motion was seconded by Council Member Staton and passed by unanimous vote.

Mayor Pro-Tem Morgan made a motion to accept the budget ordinance, calendar and fee schedule for FY2017-18. The motion was seconded by Council Member Bivens and passed by unanimous vote.

Adjourn

Council Member Staton made a motion to adjourn the meeting at 7:35pm. The motion was seconded by Mayor Pro-Tem Morgan and passed unanimously.

Section 3: Levy of Taxes

There is hereby levied a tax at the rate of fifty-one cents (\$0.51) per one hundred dollars (\$100) valuation of property as listed for taxes as of January 1, 2017, for the purpose of raising the revenue listed Ad Valorem Taxes 2017-2018 in the General Fund Section 1 of this ordinance. This rate is based on a valuation of property for purposes of taxation of \$172,947,564 (real and personal property of \$155,883,278 and motor vehicles of \$17,064,286) and an estimated rate of collection of 97.5% and 99% respectively.

There is hereby established, for Fiscal Year 2017-2018, various fees and charges as contained in Section 3 of this document.

Section 5: Special Authorization of the Budget Officer

- a) The Budget Officer shall be authorized to reallocate amounts between line item expenditures within a department without limitation and without a report being required.
- b) The Budget Officer shall be authorized to execute transfers for contingency appropriations, not to exceed \$5,000. Notification of all such transfers shall be made to the Town Council at its next meeting following the transfer.
- c) The transfer of funds from one department to another department, excluding contingency appropriations, shall be accomplished only with prior authorization of the Town Council.

Section 6: Utilization of the Budget Ordinance

This ordinance shall be the basis of the financial plan for the Town of Marshville municipal government during the 2017-2018 fiscal year. The Budget Officer shall administer the Annual Operating Budget and ensure the staff and elected officials are provided with guidance and sufficient details to implement their appropriate portion of the budget.

Section 7. Copies of this Budget Ordinance

Copies of this Budget Ordinance shall be furnished to the Clerk, Town Council, Budget Officer and Department Heads to be kept on file by them for their direction in the disbursement of funds.
