# **Town Council Meeting**

# Monday, May 17, 2010 at 7:00 PM

# Marshville Town Hall - 201 W. Main St.

Present: Mayor Deese, Council Members Matthew Jefferson, Ned Beachum, Denise Whitley, Dora Bridget, Mayor Pro-Tem Bivens, Town Administrator Radford Thomas, Interim C/FO Tonya Johnson, Attorney Bobby Griffin, DPW Steele, PD Thifault, and Chief Gaddy. Also, present were John Edmondson, *The Home News*, and Lacy Hampton, *The Enquirer Journal*.

#### **Regular Meeting**

Mayor Deese opened the meeting at 7:00 p.m. and welcomed everyone in attendance. The invocation was given by Council Member Whitley. All gave the Pledge of Allegiance.

#### **Public Comments**

Ruth Sturdivant – 803 Sanford St., Marshville – concerned about Cyber Center and its regulation and safety issues. Her daughter works 2<sup>nd</sup> shift at Autumn Care. Her daughter's boyfriend was involved in a fight in the parking lot involving two guys lurking around from the Cyber Center. It is not regulated and there is no parking. There appears to be gangs of people around the Cyber Center just hanging out. She doesn't feel safe. Mayor Deese commented that he attended a NC League meeting in Raleigh where this was discusses. It seems legislation is pending that will look into these types of places, which may take care of issues such as Mrs. Sturdivant's. Mayor Pro-Tem also commented on the loitering after people go to the Cyber Center. She suggested the possibility of some parking limitations. Council Member Whitley agreed the concerns are valid. Looking into legislation to resolve these types of places.

# Set date for budget work sessions

TA Radford Thomas recommended Tuesday, May 25<sup>th</sup> and Thursday, May 27<sup>th</sup>, 2010 for budget work sessions.

A motion was made by Council Member Denise Whitley to call a special meeting of the Town Council on May 25 and May 27 for the purpose of budget work sessions. The motion was seconded by Council Member Dora Bridget. Vote: All ayes.

# Approve Resolution for Council-Manager form of Government

TA Thomas explained that the resolution would authorize our legislator, on council's behalf, to introduce a bill to change the town's charter. Council Member Whitley commented that she feels we need to take this first step.

A motion was made by Council Member Whitley to adopt the Resolution for Manager-Council Form of Government. The motion was seconded by Council Member Ned Beachum. Vote: All ayes.

Comments: Mayor Deese questioned if the wording should be changed to Council-Manager, instead of Manager-Council. Council Member Whitley suggested this be effective as of 07/01/2010.

## Comments

PD Thifault commented on the concert that was held at HeBrews Coffee. He is planning another concert on 6/25/2010 that will involve the police, sheriff, and fire departments. He will have more information forthcoming.

DPW Steele gave out a copy of an email he received updating the Mayor and the Council on the CMAQ Sidewalk Project.

Chief Gaddy explained changed in the stop lights on 74. The turning lane signal as Food Lion is working properly. It now is a blinking caution. The signals at White St. and Elm St. are being worked on. It seems that break-ins are picking up. The department is staying busy.

Council Member Whitley commented that the event at Hebrews Coffee was good. She commended Alan for his help in organizing the event.

Council Member Bridget had no comments.

Mayor Pro-Tem Bivens asked what can be done regarding the congregating and parking issues at the Cyber Center. She feels there needs to be regulations about parking. Chief Gaddy replied that there are no ordinances at this time. In Short Session, it may be taken care of. TA Thomas commented that he and Chief Gaddy were studying the idea of parallel parking on both sides of the street and doing away with angled parking. Typically, narrower streets tend to slow traffic. Mayor Deese feels that this calls for some serious thought before making any changes. TA Thomas commented that he's not sure if this would be better or not. He is looking at options to address parking and loitering. He is concerned about parking around the Community Center. Mayor Pro-Tem Bivens expressed that she is pleased at the decision to adopt the resolution to change the form of government and amend the charter. She also expressed concern about animal control problems around town.

Council Member Jefferson stated he wants the Cyber Center gone. He doesn't see any benefit from it. He commended council, TA Thomas, and the mayor on adopting the resolution to change the form of government and amend the charter.

Council Member Beachum talked about several streetlights being out. He doesn't understand why Duke Power can't fix the streetlights. Chief Gaddy said he will follow up with Duke Power. TA Thomas was directed to make a call to Duke Power regarding the streetlight issue.

TA Thomas handed out a DOT letter regarding a special study he requested for the possibility of a connector of the proposed bypass to Project Legacy. He also informed council that Centralina COG is moving their offices effective May 24, 2010. The budget process is coming along. The NC League is having 2010 Town Hall Day on Wednesday, June 16, 2010. Mayor Deese commented that there have been several complaints in the past about legislators' not being available. The League is asking you to make an appointment in advance with your legislator.

A motion was made by Mayor Pro-Tem Bivens to go into Closed Session (per  $G.S.\ 143-318.11(a)(3)$  to consult with an attorney concerning the handling or settlement of a claim, judicial action, mediation, arbitration, or administrative procedure...). The motion was seconded by Council Member Dora Bridget. Vote: All ayes.

At 7: 45 p.m. a five minute recess was called and department heads were dismissed

Whereas, the Town Council of the Town of Marshville has previously in open sessions and at its annual discussion "retreats" analyzed the need for a Manager-Council form of government; and

Whereas, a Manager-Council form of government will provide for consistency in hiring, evaluations, promotions of employees and will promote professionalism among staff and employees; and

Whereas, a Manager-Council form of government will provide Council with more opportunity to engage in policy analysis and goal setting for the future of the Town of Marshville, and less on daily operational tasks; and

Whereas, a Manager-Council form of government will be in the best interest for all the residents of the Town of Marshville now and in the future as growth and change occur.

BE IT NOW THEREFORE RESOLVED THAT THE TOWN COUNCIL OF THE TOWN OF MARSHVILLE REQUESTS THAT HONORABLE PRYOR GIBSON, REPRESENTATIVE IN THE NORTH CAROLINA LEGISLATURE WHO REPRESENTS THE DISTRICT WITHIN WHICH TOWN OF MARSHVILLE IS LOCATED, INTRODUCE AND CAUSE TO BE ENACTED A STATUTE THAT PROVIDES THAT MARSHVILLE BE GOVERNED BY A MANAGER-COUNCIL FORM OF GOVERNMENT, TO BE EFFECTIVE JULY 1, 2010.

BE IT FURTHER RESOLVED THAT THIS RESOLUTION BE SENT BY THE MAYOR AND PRESENT ADMINISTRATOR TO THE HONORABLE PRYOR GIBSON TONIGHT THE  $17^{\rm TH}$  DAY OF MAY, 2010.
